NEW ADMISSION FOR CLASS VI / IX AT SAINIK SCHOOL BIJAPUR: AISSEE – 2025-26

Dear Parent / Guardian.

- 1. It is intimated that, Merit List / Result of All India Sainik Schools Entrance Examination (AISSEE) held on 05 Apr 2025 has been published by National Testing Agency (NTA). Only qualified / shortlisted candidates in the e-counselling portal i.e. AISSAC will be eligible for Medical Examination followed by Provisional Admission on the scheduled day (subject to medical fitness) for class VI / IX at Sainik School Bijapur. Your son / daughter has to appear for the Medical Examination and Provisional Admission (Subject to Medical Fitness) as per slot / dates given at the time of e-counselling.
- 2. You are required to submit the documents before the **Medical Board** as mentioned in **paragraphs 9 & 20**, failing which he/she will not be allowed to appear for the Medical Examination and the reservation clause would not be applicable. Further you are also required to submit the List of documents for **Provisional Admission mentioned in paragraph 20** of this letter. All eligible Parents/candidates are requested to go through this letter and keep all documents well in advance to avoid inconvenience during Medical Examination and Provisional Admission.
- 3. Your son / ward/ daughter will be examined by the Medical Team of Specialists at Sainik School Bijapur.
- 4. After verification of the documents, your son / ward/ daughter will be medically examined by a Medical Board on the same day. A sum of Rs.100/- will be charged to you, towards Initial Medical Examination. Prior to appearing for Medical Examination, the parents are advised to ensure that both the ears of your ward are properly cleaned preferably by the ENT Surgeon of your own choice. There should not be any wax content in the ears when the candidate appears before the Medical Board. If the candidate is found **UNFIT** by the Medical Board at Sainik School Bijapur, they will be referred to the Command Hospital, Air Force, Bengaluru for Re-medical / further action at their own expenses. A sum of Rs.100/- will be charged towards Referral / Re-Medical cases.
- 5. Medical fitness and qualifying in the Medical Examination does not guarantee you any right for the admission of your child on the basis of marks secured in the written examination. Admission will be finalized/ confirmed on the basis of submission of requisite documents, fees and Medical fitness.
- 6. In case your son/ ward/ daughter does not report for Medical Examination on the date and time specified above, it will be presumed that you are not interested in admitting your son/ ward/ daughter. The next candidate in the order of merit will then be given a chance. **Any Change in date for Medical Examination will not be entertained**.
- 7. "MERIT" in respective category will be the sole criteria for admission into school. No recommendations will be accepted. Any attempt on the part of a candidate or parent directly or indirectly to influence regarding admission would be treated as a disqualification and candidature of such candidates is liable to be cancelled.

- 8. You are required to bring an **AFFIDAVIT OF INCOME** on non-judicial stamp paper worth Rs.100/-declaring your monthly income from all sources as on 01 Apr 2025 giving the breakdown of basic pay, DA, CCA, HRA etc. including income of self, wife and child (shown separately) on the **date of Medical Examination**.
- 9. <u>DOCUMENTS REQUIRED FOR MEDICAL EXAMINATION: IN RESPECT OF GENERAL / SC / ST / OBC (NCL) & DEFENCE CATEGORY CANDIDATES:</u> Please note that the following documents are only acceptable as evidence of age and other criteria for eligibility for admission to the Sainik School. 

UNDERTAKING FROM THE PARENT & CADET (SSS Rules)

- 1. The primary aim of Sainik Schools is to prepare the boys academically, physically and mentally for entry into the National Defence Academy. In order to achieve this aim, extra classes are conducted for the cadets. In addition, the school will be conducting personality development and SSB orientation programmes by engaging the services of qualified expert. The government invests a lot of money by providing scholarships in order to encourage the cadets to join NDA. A cadet who does not show any interest in attending these classes and gives applications asking to be excused from attending programmes organized by the school/indulging in indiscipline is willfully going against the laid down rules and regulations.
- 2. As per Rule 3.38 of Sainik Schools Society Rules & regulations, all students are liable to appear for tests, interviews and medical examination training Institutions to which they are to report. Failure to fulfill this liability, or attempts to leave these Institutions prematurely or willful attempts on the part of such boys to undertake this as a procedural formality only will make the parents/guardians liable to refund the entire amount of scholarship/subsidy enioved by such students.
- 3. Similarly as per Rule 3.32 and Rule 4.11 of Sainik Schools Society Rules & regulations if the conduct, behavior or influence of a cadet is detrimental to the general discipline of the school, or if the academic performance is not up to the laid down standard, the scholarship money may be withdrawn and necessary steps will be taken to refund the schools.
- 4. IF CADET INDULGES IN ACTS OF INDISCIPLINE LIKE BUNKING, NOT ATTENDING FALL INS. NOT COMING ON TIME, CAUSING DAMAGE TO SCHOOL PROPERTY, LUSING HEATERS. BRINGING MESS UTENSILS/ MESS FOOD TO HOUSES, USING MOBILE PHONES, AND ELECTRONIC GADGETS, BEING ABSENT WITHOUT LEAVE, SHOWING DISRESPECT TO THE STAFF IN ANY MANNER AND OTHER ACTS OF GENERAL INDISCIPLINE, IT WILL LEAD TO DISCIPLINARY ACTION AGAINST HIM, LEADING TO EXPULSION FROM THE SCHOOL AS WELL AS RECOVERY OF THE SCHOLARSHIPS/SUBSIDIES IN FULL.
